In pursuance of resolution of the Department of Higher Education, Govt. of Odisha notified vide No. HE-FEIR-MISC-43/2016-7883/HE Date: 04/04/2016 and Syndicate resolution No. 46 dtd. 28.05.2016 Career Advancement Scheme (CAS) is implemented in Sambalpur University as enumerated in the Higher Education Department Resolution NO. 44032 dated 06.10.1989 subject to the condition that their other terms and conditions of Service shall remain unaltered as specified below:

For the teachers of this University whose cases are pending for consideration under CAS, the following will apply.

Those, who have become eligible for CAS promotion by 31.12.2008, their promotion will be as per UGC Regulations, 2000 and University Statute, 1990, as amended from time to time.

(ii) Those, eligible for CAS between 31.12.2008 to 24.09.2013, their promotion will be as per UGC Regulation, 2010 and University Statute, 1990, as amended from time to time, concerning calculation of API score for allowing promotion to Reader/Associate Professor/ Professor grade.

(iii) Those eligible on or after 25.09.2013, shall be governed under UGC Regulations, 2013 and University Statute, 1990, as amended from time to time, concerning capping of scores under

different category of research and publication activities.

2) The above said Academic performance Index (API) score involving research publications, research projects, research guidance, attending National/International conference etc. shall be calculated as per the UGC Regulation, 2010 and 2013 respectively.

Eligible Teachers of the University may apply in the prescribed format for the promotion; General Instructions:

The prescribed application form (PBAS Proforma) and other information can be downloaded from the Sambalpur University website http://www.suniv.ac.in/IQAC/pbas-proforma.php. The filled-in application form signed by the candidates must be submitted along with a Non-Refundable Bank Challan (format enclosed) of Rs.700/- (Rs.350 for ST, SC and Women) drawn in favour of the 'Comptroller of Finance, Sambalpur University', payable at State Bank of India, Jyoti Vihar Branch, Burla, Odisha, Power Jyoti A/C No. 34139360373. Applications without the Bank Challan shall not be considered. The 'University Copy' of the Challan should be attached with the application. Those who have earlier applied for promotion under CAS and whose cases are yet to be assessed for promotion for the same post need not pay the see again.

The application form duly filled in by the candidate must be supported by self-attested copies of all certificates, mark sheets, evidence of teaching, research experience and production of Ph.D. scholar,

copies of published articles, certificate containing the record of date of birth etc.

3. Candidates are required to submit one copy of filled-in Application forms in the prescribed format with one sets of self attested photocopies of certificates, mark sheets, research publications and other documents. The application, through proper channel must reach the Registrar on or before 30.06.2020.

Application submitted not in the University prescribed format shall be summarily rejected.

Candidates for the post of Professor and Reader are required to submit the API Score Card in the prescribed format along with the application form. For detail of the API score please visit the UGC Web Site for Notification No. F.1-2/2009/EC/PS Dated 13.06.2013.

Candidates are required to attend the Interview if required, on their own expenses. No TA/DA etc.

shall be paid for the purpose.

Candidates are required to produce their original Certificates and Mark sheets/testimonials for verification at the time of interview if required.

The period of time taken by candidates to acquire M.Phil. and/or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions.

The candidate needs to authenticate each page of the application form and enclosures by his/her full signature on each page.

10. Applications received in incomplete form or not in prescribed format shall be rejected.
