## <u>General Terms and Conditions for Restoration of OFC Network with repairing/replacement of networking</u> <u>equipments for e-Governance network in University Campus</u>

(Ref. No.<u>075</u> /17-18/e-Gov. dated <u>06/03/2018</u> )

- 1. The bidder must be a registered company/firm under the Indian Companies Act/Odisha Commercials Act.
- 2. The bidder must have up-to date GST, PAN and other relevant documents.
- 3. The Financial Statement must be given as per Annexure-A, however the vendors are requested to visit the University campus for exact requirements.
- 4. All the documents should be enclosed with a sealed envelope and must be superscripted as "Restoration of OFC Network with repairing/replacement of networking equipments, Ref. No 195/17-18/ e-Gov. dated 06/03/2018".
- 5. The required items i.e. 6 Core Optical Fibre Cable, Joint Enclosures, Pigtails, Patch Cords etc. for repairing of OFC network must be of a reputed brand/make.
- 6. The digging work must be 2 feet inside the earth and cable laying must be with HD Pipe. Further, there will be minimum one ring of 20 Mtrs of cable.
- 7. If the Network Switch is required to be replaced with other than specified make & model in 'Annexure-A', the replaced Network Switch must be compatible with the existing SFP Port/Module and its other related networking devices/equipments.
- 8. If the Access Point is required to be replaced with other than specified make & model in 'Annexure-A', the replaced Access Point must be compatible with the existing cloud management software and its other accessories.
- 9. The vendor has to integrate and test with existing network.
- 10. The bidder should be capable of giving proper maintenance support for minimum of two months after successful completion of the work as and when required.
- 11. Bidders, who have not satisfactory completed any of the earlier contracts with our University, will not be eligible for participation in this tender.
- 12. The companies or vendors, bidding for the above tender, should have not black listed by any of Government Authority or Public Sector Undertakings (PSUs).
- 13. The bidder will be allowed to bid in Indian Rupees only.
- 14. The bidder has to submit an EMD of Rs. 3,000/- (Rupees Three Thousand) only which is refundable, in shape of demand draft in favour of Comptroller of Finance, Sambalpur University, payable at SBI, Jyoti Vihar, Burla, with the bid.
- 15. The University will not entertain any joint bidding (by two or more vendors).
- 16. The Director, e-Governance Nodal Centre, Sambalpur University will be the single point contact for all purposes.
- 17. The bidder has to have prior permission of the University before making any alteration to the existing network, should there be a need for such alteration.
- 18. The payment shall be made after completion of work successfully and after submission of successful job execution report as per University norms.
- 19. The University shall have the rights to alter, modify or delete any term and condition before finalization of the bid.
- 20. The authority reserves the right to reject any or all quotations or accept any without assigning any reason thereof.

The quotations complete in all respect should only be considered, so the vendors are required to visit the University Campus for their convenience before submission of their proper quotations.
