If this day is declared later as a University holiday, the tenders will be opened on the next working day as per the scheduled time. Delay in postal delivery will not be taken into consideration. The tender cover should be superscribed as "TENDER FOR VEHICLE".

No tender will be considered without the earnest money. Bank draft towards EMD will be returned to the unsuccessful tenderers only after finalization of the tender.


The intending tenderers may inspect the vehicle at the University premises on any working day between **01.00P.M to 04.00P.M. from date 20.07.2018 to date 09.08.2018.**

The tender whose offer will be accepted by the University Authorities shall have to deposit 25% of the offered amount for the vehicle on the spot and the balance amount within seven days from the issue of the intimation letter, failing which the offer will be cancelled and all the deposits including the earnest money will be forfeited. The vehicle should be removed from the site within seven days from the date of full payment of the bid amount.

All the charges for transfer of ownership is to be borne by the successful tenderer.

In case the vehicle is not removed, the custody and safety of the vehicle shall be the responsibility of the tenderer and no claim or complain on that account shall be entertained and ground rent as per University rule will be charged.




