Sir,

I am directed to intimate you that the Academic Council in its meeting held on 19.05.2019 has approved the syllabi for **B.Ed. & M.Ed. courses due to start from the academic session 2018-19.** It will be same as the syllabi followed during previous academic session.

Further the Academic Council has also approved the recommendations of the Board of Studies in Education related to amendments in **B.Ed. & M.Ed. Regulations.** The said recommendations are as follows: -

- (a) Recommended that the evaluation of all practical papers of B.Ed. 2nd year Course will be internal only. The existing practice of External examiners be abolished from the academic session 2019-20 onwards. This may be incorporated in the concerned regulations.
- (b) Recommended that in the M.Ed. Course of 4th Semester, regarding evaluation of the Dissertation work, out of 100 marks the candidate will be assessed by both the external examiners and Internal examiners instead of the existing 50 (Internal) +50 (External) on dissertation work. At the end of the Semester (4th) it will be assessed. It may be incorporated in the regulation.

This may be notified and be made available to the teachers and students concerned of your college/ department/ institution. You are further requested to ensure teaching of the courses accordingly. Any error and omission etc. may kindly be intimated to the undersigned.
