

**PROCEEDING OF THE DISTRICT LEVEL WORKSHOP MEETING ON "ODISHA
PROCUREMENT PREFERENCE POLICY FOR MICRO AND SMALL MANUFACTURING
ENTERPRISES 2023 BY STATE GOVERNMENT ORGANIZATION" WAS
HELD ON 18.10.2025 AT 11.00 A.M. IN THE SSA CONFERENCE HALL, SAMBALPUR**

The District Level workshop meeting on "Odisha Procurement Preference Policy for Micro and Small Manufacturing Enterprises 2023 by State Government Organization" was held on 18.10.2025 at 11.00 A.M. in the S.S, Conference Hall, Collectorate, Sambalpur under the chairmanship of the Additional District Magistrate (Gen.) Sambalpur.

At the outset of the workshop meeting the General Manager, DIC, Sambalpur welcome to the Chairperson and Representative of the Director, EPM, Bhubaneswar, Govt. of Odisha as well as all the District Level Officers of Sambalpur District and stated as mentioned. Members present in the said workshop is enclosed at Annexure -A.

The Additional District Magistrate (Gen.) Sambalpur briefed key address to the participant.

- That Govt of Odisha has been taken good step to boost manufacturing activities in the state, Micro and Small manufacturing Enterprises located in odisha will be given some preference and relaxation as per Odisha Procurement Policy -2023.
- On investment of Plant & Machinery upto Rs.10 crores and turn over of Rs.50 crores annually will be categories as OSMEs, along registered with Start -Up Odisha

Dy. Director, Testing laboratory, Govt. of Odisha has presented Odisha procurement Preference Policy MSMEs 2023 through PP mode and as stated below.

- The Procurement Policy-2023 is applicable to all State Government Department and their subordinate offices/authorities , functioning under administrative control of State Govt & located in the State of Odisha wherein procurement of goods is done out of State Govt. fund or State Government arranged fund.
- As per Govt. of Odisha Rate of contract Rules -2014, DEPM is under the control of MSME deptt. and enters into rate of contract agreement , having specified validity period with selected OSMEs for supply of goods of specified quality at specified rate. Valid rate contract are available in the website of DEPM. Procurement of goods shall be mandatorily done from any such rate contract holder as per the particular rate. Goods can be procurement from multiple rate contract holders. No tender / bidding shall be done amongst rate contract holders. Preference shall be given to rate contract holders of the concerned district. Procurement of such goods outside Rate contract system is not allowed.
- Procurement of such goods shall be made on the basis of competitive bidding through intra- state tender amongst OSMEs .
- Procurement of goods not covered under Rate contract and Exclusive list shall be made through open tender procedure.

- Govt of Odisha facilitate the growth of OSMEs by making this procurement preference policy, OSMEs will not compromise on quality & timely delivery of goods to be procured from them by the procuring article. In case of any deficiency in quality , quantity or timely delivery of goods ordered for procurement, the procuring entity concerned will be free to take suitable action against the defaulting OSMEs, including blacklisting from future procurement for certain period.
- The procurement preference Policy is intended to facilitate sale of goods manufacturing by OSMEs not from some other supplier and selling under its own name. Only benefit will be given to actually manufactured by them in their own industry located in Odisha. If any complaint is received alleging supply of non-self manufactured goods by any OSME availing benefits of this Procurement Preference Policy, procuring authorities shall refer the matter to the G.M, DIC of the concerned Dist. in which OSME concerned & located. The GM DIC will enquired into mater by help of relevant Govt. authorities and give a report to the procuring authorities concerned.
- MSME Department will be the Nodal Department and Director (EPM) shall be the Nodal Officer (State Level) for monitoring implementation of this policy. GM (DICs) of each district shall be Nodal Officers at concerned district Level. Procuring entities may contact concerned GM, DIC for any query of this policy. Aggrieved OSMEs may also contact respective GM, DIC for redressal of grievances.

At the end of the workshop meeting the Additional District Magistrate (Gen.) Sambalpur was requested to all DLOs to follow the Odisha Procurement Preference Policy for Micro and Small Manufacturing Enterprises 2023 during procurement goods in the District Level Offices.

The workshop meeting ended with vote of thanks to the Chair.
