NOTIFICATION

It is for information of all concerned that the Vice-Chancellor in exercise of his power vested under sub section 15 of section 6 of the Odisha Universities Act. 1989 has been pleased to approve the recommendation of the members of Multi-Disciplinary Board of studies as follows.

1. Each P.G. Student shall have to study three (03) MOOCs /SWAYAM papers ($3 \times 4 = 12$) in second and third semester and has to clear by end of fourth semester.
2. Each student shall study two papers for eight (08) credits in second semester and the third paper for four (04) credit in third semester from MOOCs/SWYAM.
3. The MOOC/SWAYAM papers to be taken by student will be from same/other discipline different from his own area of Master Degree and should be of multidisciplinary in nature.
4. The MOOC/SWAYAM courses will be chosen by the students under the constitution of the respective faculty members of the department.
5. Each student has to earn a certificate from MOOCs/ SWAYAM by passing the Examination conducted by the respective course coordinator of MOOCs/ SWAYAM platform and has to submit a copy of the same to the department for incorporation of the earned credits in his/her degree certificate.
6. In case the course coordinator of the MOOCs/ SWAYAM platform is unable to conduct the Examination for the course for whatever reasons, the student may clear the Examination to be locally conducted by the Sambalpur University.
7. Each Board of Studies under Sambalpur University shall identify at least five to six (5-6) to be opted by the students through MOOCs/SWAYAM platform.

This will be effective from 2022-23 admission batch.
