## **Sambalpur University at a Glance:**

Sambalpur University, an institution of higher learning encourages students to come to learn and go to serve the state and the society. Thus, it acts as a catalyst for social transformation. It obtained an impressive A-Grade from the NAAC in its third cycle of re-accreditation. The Mahatma Gandhi National Council of Rural Education (MGNCRE), Department of Higher Education, has also awarded the University-The District Green Champion 2021-22 for the exemplary work done in making a difference to the campus and its neighborhood. Way back in 1967, it was a tiny institution, functioning at Patna House, Sambalpur. ## **Department of Home Science at a Glance:**

It imparts M.A/M.Sc. teaching in Home Science Course with two specializations i.e. 'Human Development & Family Studies' and 'Food and Nutrition'. ### **Concept Note:**
