CONCEPT NOTE ABOUT THE SEMINAR

History, once considered a fixed and singular narrative, is now undergoing a vibrant reimagining. This Seminar, "ODISHA'S PAST REIMAGINED: NEW HISTORICAL PERSPECTIVES AND UNEXPLORED DIMENSIONS" aims to showcase these exciting developments and engage in a critical dialogue about the recent developments in history and archaeology of Odisha. Since the first discovery of palaeolithic implements in Odisha by Valentine Ball at Bhursapali in Sambalpur district in the year 1875, marked the beginning of a systematic exploration of Odisha's archaeological treasures. Over the years, numerous excavations and studies have uncovered a plethora of artifacts and structures, shedding light on the ancient civilizations that once thrived in the region along the different river valleys. A large number of young scholars from different Universities have explored many important river valleys along with their tributaries have brought to light many archaeological sites from the prehistoric to historical period. Moreover, the history of Odisha is often overshadowed by the dominance of major dynasties. Furthermore, the history of Odisha is not confined to grand temples and monumental structures. The everyday lives of its people, their struggles, triumphs, and cultural assimilation, are equally integral to the narrative. The ancient trade routes that crisscrossed the state, the agricultural practices that sustained communities, and the evolution of indigenous crafts – all contribute to a holistic view of Odisha's history. Reimagining Odisha's past also necessitates a reassessment of its role in larger historical events. For instance, during the Kalinga War, the land witnessed a transformation that eventually influenced Emperor Ashoka's embrace of Buddhism. Exploring the impact of such pivotal moments on the socio-religious landscape of Odisha can provide a fresh perspective on its historical trajectory. However, a closer look at the local and regional

rulers who flourished in relative obscurity can offer valuable insights. The modern urbanisation process has also made significant changes in the development of tribal community and displacement from their native places. The Western Odisha played a crucial role in India's struggle for independence, as many unknown heroes from rural villages in the area made noteworthy contributions to the cause. Among these courageous men, the remarkable freedom warrior Veer Surendra Sai and his brother Chhabila Sai are particularly prominent. Regrettably, Chhabila Sai met his demise in an ambush in Kudopali village on December 13, 1857, masterminded by Captain Wood, leading to the loss of not only Chhabila Sai but also his loyal disciple. This event represents the resolute dedication from Western Odisha to the resistance against British colonial rule. The sacrifices and efforts made by them emphasize the historical importance of the region in the wider context of India's struggle for independence. The main objectives of this seminar are to offer a comprehensive exploration of the state's history right from prehistory to Modern phase, presenting new perspectives and unexplored dimensions. In conclusion, Odisha's past, when reimagined through new historical perspectives and unexplored dimensions, unfolds as a narrative rich in diversity and complexity.

ABOUT PROF. N.K. SAHU MUSEUM

The Post Graduate Department of History, Sambalpur University opened its museum in 1970 for collection, preservation and documentation of the invaluable antiquities within a decade it has made considerable progress in the work for which it was started. At present the museum comprises pre-historic tools from different parts of Orissa and Assam, excavated potteries and other archaeological objects from Asurgarh (Kalahandi district) and Manamunda (Phulbani district), some interesting coins and sculptures, copper plate inscriptions ranging from 4th Century A.D. to 19th Century A.D. and a few lithic epigraphs. It has also preserved punch marked coins from Kalahandi district, Puri-Kusana coins from Purusottamapur and Bhilingi, Sarabhapuriya gold coins from Nehena (Nuapada district), a few gold coins probably issued by the Chedis and the Kusanas, some gold fanams of the imperial Gangas from Subarnapur, some gold and silver coins of the medieval period, coins of the British-East India Company and princely states as well as a few terracotta seals. War implements of the 19th Century, brass objects of the same period, musical instruments

and other objects of the tribal people and painted portraits are some of the interesting collections of the museum.

- 2. Each paper should include the following sections: (i) Introduction, (ii) Materials

and methods, (iii) Results and Discussion (v) Conclusion, and (vi) References.

- 3. The full paper should not contain more than 4000 words.
- 4. A paper should not exceed 10 pages. References should be as per the APA style.

The abstracts should not be more than 300 words composed as running matter without any formatting in MS Word file (Times New Roman font 12-point, should be typed in 1.5 spacing). Abstracts and the papers should be sent to histconfsu@gmail.com within the stipulated dates as mentioned above.
