Department of Economics, Sambalpur University invites Abstracts and subsequently full-length research papers for the National Seminar on "Development Challenges and Opportunities in Odisha" to be organised by it during February 11-12, 2025 (Tuesday-Wednesday). Authors must submit their papers addressing any suggested/indicative sub-themes or there abouts. We encourage paper writers from other disciplines of social and natural sciences as well to submit papers.

About the Theme "Development Challenges and Opportunities in Odisha"

Odisha continues to be a poor State with low per capita GSDP of Rs1,69,496 (10th among 17 major states) in 2023-24, though in the recent years it has continuously experienced high growth rates. Agricultural sector which employs more than 50% of the workforce, experiences a growth 3.5% at constant prices. To become a developed state it needs to experience structural transformation and shift of workforce to the service and industrial sectors. Progress in education and skill development is essential for this. At present the gross enrolment ratio (GER) in Higher education in Odisha is less than 22%. So to reap the demographic dividend there is a need for the promotion of this sector. There is improvement in health performance, but still its rank in life expectancy rate 8th, in IMR 12th and in MMR 14th out of 17 major states of the country as reported in the Odisha Economic Survey 2023-24. Nutrition of the children and women is an important area of concern. The head count ratio of Odisha in the multi-dimensional poverty ratio is higher than the national average. While quality infrastructure is a prerequisite for transformation of the economy, Odisha suffers from infrastructure bottlenecks and especially in some parts of the state. There is rural urban divide in the facilities and disparity in the access to opportunities available to different groups of population. The weaker section consisting of the scheduled tribes and scheduled castes face multiple deprivations. Many of them are forced to migrate from their native place to other states as seasonal or short duration migrants for survival. The state suffers from creating adequate sustainable livelihood for such people. To become a developed state it needs to diversify and intensify its economic activities not only to stop distress migration but also to create high-paid livelihood opportunities. However, the state is no dearth of opportunities. The natural resource endowment, the human capital potential, the strong will power and commitment of the Government for investment in critical infrastructures are the positive aspects for the state for tremendous economic growth. Steps are taken to attract private investors. The fiscal health of the state has improved especially after the introduction of the FRBM Act, 2004. The state economy has remained resilient in the face of economic fluctuations due to its prudent fiscal management. However, the state can use some amount of borrowing for investing in infrastructure and poverty reduction.

This National Seminar on "Development Challenges and Opportunities in Odisha" aims at an in-depth analysis of the key development challenges faced by the economy and will try to identify the plausible opportunities available for the development of Odisha.

Sub- Themes of the Seminar:

- 1. Macro-economic scenario and sectoral issues of Odisha
- 2. Social Sector issues (Education, Health and Nutrition)
- 3. Fiscal Scenario
- 4. Regional Disparities and Migration

- Title of the Paper
- Name(s), institutional affiliation(s), contact number(s) and email-id(s) of author(s)
- · An abstract of about 400-500 words

The length of the paper should be limited to 7000 words including tables and references. Papers should be typed in Times New Roman with a font size 12 and line spacing of 1.5 pt. Papers should be submitted only in electronic format.
