1. **Request for Quotation(RFQ): -**

- The Registrar on behalf of Sambalpur University invites sealed quotations for “**Supply of Track & Field (Athletics) Equipment**” for Sambalpur University as per the specification given in Annexure- “III” from eligible registered Vendor/Firm/Manufacturer.

2. **BID Schedule and Address: -**

3. **Deposit of EMD: -**

- An amount of **Rs. 19,000/-** in the shape of a Banker’s Cheque/ Demand Draft/Pay order issued from any nationalized bank drawn in favour of “**The Comptroller of Finance, Sambalpur University**” payable at Jyoti Vihar, Burla shall be submitted along with quotation documents.
- The EMD of the successful bidder shall be returned after the successful submission of the Bank Guarantee/ Security Deposit and for unsuccessful bidder(s) it will be returned after the award of the contract. Bid(s) received without a demand draft of EMD will be summarily rejected.
- Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with the stipulation made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.
- The firms who are registered with Micro, Small, Medium Enterprises (MSME) / National Small Industries Corporation (NSIC) are exempted from submitting the EMD (A copy of registration must be provided along with the technical bid).
- The EMD, in case of unsuccessful Bidders, shall be retained by Sambalpur University, Burla till the finalization of the tender. No interest will be payable by Sambalpur University, Burla, on the EMD.

4. **Scope of work: -**

## Tender for Supply of Track &amp; Field (Athletics) Equipment

- The cost of delivery and supply of equipment will be sole responsibility of the bidder. No separate payment shall be made in this regard. Also, in case of any breakage during delivery, the bidder shall ensure that the equipment is replaced at the bidder's cost. In case any supplied equipment is not as per the specifications or has a manufacturing defect, the cost of replacement will be in the scope of the bidder at no additional cost to Sambalpur University.
5. **Due Diligence:** -
- The Bidders are expected to examine all instructions, terms, and specifications stated in this RFQ.
  - The Bid shall be deemed to have been submitted after careful study and examination of this RFQ document. Failure to furnish all information or submission of a bid not responsive to this RFQ will be at the Bidders' risk and may result in the rejection of the bid. Sambalpur University is not bound to disclose the grounds for the rejection of the Bid. The decision of Sambalpur University regarding the final declaration of the successful Bidder shall be final.
6. **Eligibility Criteria:** -
- The invitation to bid is open to all Bidders who qualify for the Eligibility Criteria as given below. Failure to provide the desired information and documents may lead to the disqualification of the Bidder.
  - *The Bidder should be a GST-registered vendor.*
  - The Bidder should not be currently blacklisted by any Government / Government agency/ Bank/ institution in India or abroad. The bidder should provide a declaration to this effect on their company's letterhead (the details are attached in Annexure-I).
  - The bidder should submit the item-wise compliance and bid-specific authorization from OEM.
  - The bidder has to quote & supply all the equipment of the same Brand/Manufacturer.
  - The Equipment sl. no. 01 to sl. no. 11 should be World Athletics approved and sl. no. 12 to sl. no. 29 as per the specification of World Athletics.
  - Bidder should submit the World Athletics Certificate of approved items where applicable.
  - The bidder has to submit the equipment data sheet with the bid.
  - The bidder has quoted all the items. The partial quote will be summarily rejected.
  - The bidder has to supply the equipment within *10 days* from the date of issue of the supply order.
  - The bidder who has quoted less value as a whole will be considered as the lowest qualified bidder, and the contract will be awarded to that bidder. In case the L-1 bidder fails to supply the items within 10 days, the contract will be awarded to the L-2 bidder.

**INSTRUCTIONS TO QUOTATIONERS**

1. The bid proposals are to be sent in *sealed envelopes* subscribed with tender notice detail and addressed to as appended hereunder.

2. The bids submitted without tender documents along with Annexure –I, II, IV & V (annexure –V, Financial bid to be submitted in a separate sealed envelope) will be summarily rejected, and no further communication in this regard will be entertained. The authority reserves the right to accept/ negotiate/ reject any or all the tenders and modify the conditions/specifications at any stage without assigning any reason thereof.
3. **Opening of Tender:** The tenderer is at liberty either himself or to authorize not more than one representative to be present at the opening of the tender. The representative attending the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and proof of identification. The late received tenders by Sambalpur University, Jyoti Vihar Burla will be ignored. Further, Sambalpur University, Burla does not accept any liability and responsibility for the tenders in case the same are not properly sealed and marked and/or sent as above.
4. **Specification:** The Vendor/Firm/Manufacturer must confirm in writing that the equipment supplied by them shall be as per the specification of equipment mentioned in Annexure – “III” and in case of any variation, the contract shall be liable to be canceled immediately.
5. **Quality of equipment:** The firm will be entirely responsible for the quality of supplied equipment. The supplier should replace the rejected/ damaged items within 07 days, failing which a penalty will be imposed by the Institute.
6. **Validity:** The quoted rates must be valid for 90 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted a validity shorter than the required period, the same will be treated as unresponsive, and it will be rejected. In case the tenderer withdraws, modifies or changes his offer during the validity period, the bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The tenderer should also be ready to extend the validity, if required, without changing any terms, conditions, etc. of their original tender.
7. **Authority of person signing document:** A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind such other and if, on inquiry, it appears that the person so, signing had no authority to do so, Sambalpur University, Burla may without prejudice to other Civil and criminal remedies cancel the contract and held the signatory liable for all cost and damages.

8. **Time of Completion:** *The Successful bidder shall supply equipment within 10 days from the date of issuing the office order.*
9. **Right of acceptance:** Sambalpur University, Burla reserves the right to accept the whole or any part or portion of the bid and the bidder shall provide the same at the rates quoted. Sambalpur University, Burla reserves the right to reject any or all tenders /quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.
10. **Arbitration:** The authority reserves all the rights to cancel the process at any time without assigning any reason thereof. Any dispute arising in this case shall come under the jurisdiction of the courts of Sambalpur.
11. **Payment Terms:** The Bill in triplicate may be sent to this office for settlement after satisfactory delivery of the equipment. The bill should have full particulars of the items. No Payment shall be made in advance, nor shall the loan from any financial institutions be recommended based on the order of award of work. The Contractor shall submit the bill only after satisfactory delivery, installation, and commissioning of the material to the satisfaction of Sambalpur University, Burla. The case of issuing sanctions and passing of bills for payment will be initiated on receipt of the inspection report. No payment will be made for equipment rejected. Sambalpur University shall deduct the statutory deduction as applicable under the Income Tax Act of 1961, Odisha Value Added Tax Act of 2004, and other applicable statutory deductions.
12. **Breach of Terms and Conditions:** In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by Sambalpur University, Burla in that event the EMD shall also stand forfeited.
13. The Tenderers should furnish a copy of the GST & PAN registration number. Tenders not complying with this condition will be rejected.
14. The items will have to be supplied at the Institute site. No transportation/ cartage charges will be provided for the same.
15. Bidder shall submit a copy of the tender document and addendum/corrigendum there too, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender document.
16. **Applicable Law:** The contract shall be governed by the laws and procedures established by the government of India within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings/processing.
